To do this effectively, we are creating efficiencies in service delivery; advocating for reasonable laws impacting mental health care at the state and federal levels; recruiting and retaining a highly trained workforce; and supporting our clients in becoming productive, independent members of their communities. We believe this makes good sense not only for the people we serve, but also for Maine.

WHO WE ARE:

IT ALL STARTED WITH EIGHT BOYS IN 1960

Spurwink began with one house serving eight boys on Riverside Street in Portland in 1960. The developmental needs of the boys could not be met at home or in public school, and the roots of Spurwink were planted.

Today Spurwink is much larger, serving 8,000 people each year through the good work of 900-plus employees throughout the state. Although Spurwink's reach is bigger, our mission remains the same: providing exceptional and evidence-based behavioral health and education services for children, adults, and families so that they can lead healthy, engaged lives in the community.

This vision is the cornerstone of what we do and how we deliver services: developing positive self-regard in those we serve by honoring and respecting who they are, and then building upon the strengths of the individual and the family.

Whether it's a preschooler with autism in Saco, a teen with a trauma history in Skowhegan, or an adult with developmental disabilities in Portland, Spurwink's clients are offered dignity, respect, and a chance to build a better future.

PROGRAM HIGHLIGHTS

Spurwink's therapeutic, evidence-based programs touch many different aspects of behavioral health care. As you will see in the highlights below, we are working with refugees and in foster care; increasing access to care for the under- and uninsured; and adopting new treatment models in our residential programs and behavioral health homes. Despite the wide range of clients and clinical settings, the common thread is our commitment to continuous improvement, best practices, and a personalized treatment plan for each individual. ShifaME

Spurwink was awarded a \$2 million federal grant from the U.S. Substance Abuse and Mental Health Services Administration (SAMHSA) to participate in the National Child Traumatic Stress Initiative: Community Treatment and Services program. Spurwink is the only agency in Northern New England awarded the competitive grant. The ShifaME Project utilizes Trauma Systems Therapy for Refugees (TST-R) to improve access to trauma-informed mental health services for approximately 2,000 Maine refugee children and adolescents who have experienced complex trauma. Partners include the Refugee Trauma and Resiliency Center at Boston Children's Hospital (BCH), The National Child Traumatic Stress Network, the Immigrant Resource Center of Maine, and partnering schools in Lewiston/Auburn, Biddeford, and Greater Portland.





A Family for ME

Spurwink was awarded the “A Family for ME” (AFfME) Foster Care Recruitment contract from the Maine Department of Health and Human Services (DHHS) to increase statewide recruitment of foster parents in Maine. The grant funds a four-year partnership between DHHS and Spurwink, with the goal of raising awareness of the urgent need and finding Maine families to parent children in foster care. Foster parents are needed to provide temporary care to babies and young children who are in the process of reunification with their birth families; for larger sibling groups to allow siblings to remain connected in the same home; and for older youth with challenging behaviors.

Clinical Team Intervention and Assistance for Foster and Kinship Families

Spurwink was awarded an important new program by the Maine DHHS to provide Clinical Team Intervention and Assistance for Foster and Kinship Families in Cumberland and York Counties. This five-year grant-funded program will provide critical clinical services to foster and kinship families who are fostering children in DHHS custody.

Sensory Integration & Training

Spurwink received grants from the Davis Family Foundation and KeyBank Foundation to create and implement therapeutic sensory and gross motor activities at our day treatment sites and one of our residential programs, which will help youth maintain the emotional regulation needed to engage in functional and meaningful life activities.

Spurwink Therapeutic Preschool

Spurwink received a grant from the Sam L. Cohen Foundation to support the Spurwink Therapeutic Preschool. Funds will support “Enhancing School Readiness for Children,” providing classroom equipment, sensory materials, assistive technology & software, and curriculum materials to allow an expansion in service delivery. The funds will also support a parent/teacher education series.

Integrated Supports

The John T. Gorman Foundation approved a subgrant to Spurwink to coordinate the Integrated Supports program at Montello School in Lewiston. The grant embeds a Spurwink coordinator at Montello School to identify school and community supports for children and families to ensure children are ready and able to learn.

Building Assets, Reducing Risks (BARR)

Spurwink was awarded the U.S. Department of Education, Office of Investing in Innovation (i3) award for the Building Assets, Reducing Risks program. One of 15 grants announced, Spurwink will receive a 5-year scale-up grant to expand the model to at least 116 new schools in Maine, California, Minnesota, Tennessee, and Texas. Seventeen Maine schools have participated in the program to date through prior i3 funding, with four additional schools identified to date to participate in the scale-up project, including Auburn, Biddeford, Lewiston, and Oxford Hills. This funding will extend the powerful student achievement and social emotional outcomes demonstrated in our previous i3 Development and Validation grants. BARR's focus on relationships, data, and student strengths continues to produce amazing evidence, impacting all students and transforming school systems across the country.

Access to Care

Spurwink was awarded a grant from the Beim Foundation to provide behavioral health care to under- and uninsured youth in Cumberland County. The grant enables our Outpatient and Community Services team to provide access to care for young people in greater Portland who don't have access to critical behavioral health supports.

Immigrant & Refugee Girls' Groups

The Outpatient & Community Services teams in Cumberland and Androscoggin County completed their ShifaME girls' groups with Hall and Lincoln schools in Portland and McMahon Elementary in Lewiston. Twenty-four 3rd to 7th grade immigrant and refugee girls from Africa, Asia, Europe, and Central America, many of whom have experienced trauma, loss, and challenges navigating a new culture, participated in the groups. The Maine Women's Fund provided a grant to support the social and emotional needs of immigrant and refugee girls. In schools, boys are more often referred to services given their externalized reactions to trauma/stressors, resulting in disciplinary responses from the school, while girls are more likely to internalize the stress and disconnect from school/peers while not drawing the attention of the school for needed supports. The groups helped increase school attendance and helped girls engage socially with their peers, developing self-efficacy.





AGENCY RECOGNITION

Task Force on Maine's 21st Century Economy and Workforce

Spurwink's President & CEO, Eric Meyer, was appointed to the Task Force on Maine's 21st Century Economy and Workforce on March 30, 2017. He is one of 16 members, representing the interests of a Maine business that employs fewer than 1,000 workers. Spurwink employed nearly 900 employees in 14 of Maine's 16 counties, with recent refugees and immigrants making up 10% of the workforce. The task force is charged with strengthening Maine's economy by strengthening the workforce, particularly in areas most affected by the workforce shortage including health care. The group will submit their findings and recommendations, including suggested legislation, by March 1, 2018.

NEW APPROACHES TO CARE

Residential Redesign

To best meet the needs of our clients and invest strongly in the future of Maine's Children, Spurwink is redesigning and upgrading our children's residential services. Spurwink is growing our capacity to provide residential care to meet the statewide need for services. We also are expanding our educational day treatment services. We are transitioning our model of residential treatment from small homes to larger residential programs. There are several advantages in this redesigned approach: improved outcomes for children and youth; strong level of family engagement, clinically, socially and relationally; high level of clinical presence in the program; intensive clinical model training and supervision for all staff; strong supervisory presence at all times; and improved level of staff retention due to strong team support, training and supervision. Spurwink is financially strong and a leader in quality services in Maine. The residential redesign will increase our strength as an organization and keeps us focused on our key values.

Behavioral Health Homes for Children

Spurwink launched Behavioral Health Homes (BHH) for Children and Adults, a new and integrated approach to care, in our Outpatient Offices in Biddeford, Portland, Lewiston, and Randolph. The model offers a team-based approach to care coordination similar to targeted case management with the expanded supports of a Family Support Partner, peer supports, and clinical, medical, and psychiatric consultation.

BHH provides a partnership between behavioral health and primary care; an integrated approach to case management, including health promotion and prevention; coordination of all services involved in a child's treatment; help in identifying natural and community supports; and access to family support and education provided by a Family Support Partner, someone who has lived experience in navigating behavioral healthcare services.

Behavioral Health Homes help children and their families by creating individualized plans that address a child's whole health, including mental and physical health needs; making referrals, coordinating services, and finding resources; addressing chronic health concerns like asthma, diabetes, and obesity; and collaborating with medical providers to reduce unnecessary emergency room visits and hospitalizations.

Shared Living

Spurwink launched a Shared Living program, providing adults with intellectual disabilities or autism an opportunity to live in a supported home in the community. Shared Living offers individuals an opportunity to develop strong, supportive, often roommate- or family-like relationships with their shared living provider; become connected to and embraced by a community; foster unique interests and build new skills; and experience greater levels of independence.

Children and Residential Experiences: CARE model

Spurwink is the only Maine agency with a proven history of utilizing the CARE model (Children And Residential Experiences: Creating Conditions for Change) throughout all programs

- Started utilizing in 2014 with great success
- All staff trained in CARE model
- Designed to support safe environments, strong programmatic elements and a wide-variety of treatment programs and interventions that are trauma-sensitive and developmentally appropriate.

The California Evidence-based Clearinghouse for Child Welfare (CEBC) recently awarded the CARE program model a Scientific Rating of 3 (Promising Research Evidence) and a rating of High Relevance. Spurwink is pleased to contribute to the advancement of this clinical model.




FINANCIALS FISCAL YEAR 2017







DISCHARGES FROM TREATMENT FOSTER CARE


The length of a stay in Treatment Foster Care can vary, depending on the needs of the child and circumstances of the family of origin. Family reunification is typically the primary goal.

A positive outcome for children in Spurwink's Treatment Foster Care program occurs when they are reunified with their family or are adopted. Over half the children discharged from TFC were placed in permanent families. A second positive outcome occurs when children are stable enough that treatment level support from Spurwink is no longer necessary.




WHERE WERE DAY TREATMENT STUDENTS DISCHARGED TO?

Many of the students who attend Spurwink's day treatment programs complete treatment and return to public school. A number of others graduated or completed their education in other ways.



Two-thirds of the youth discharged from Residential Treatment in FY17 were discharged to less restrictive settings such as home, independent living, or foster care. Those same youth were primarily admitted to residential from more restrictive settings such as hospitals or correctional facilities.







OVERALL SATISFACTION WITH SERVICES FOR ALL PROGRAMS


Overall Client Satisfaction

Overall Referral Source Satisfaction


